Having regard to the above applications lodged on the dates tabulated below,

Having regard to the observations submitted by the parties,

Having noted that the Governments of Hungary, Germany, France, Greece, Turkey, Italy and Austria, respectively, whose nationals are some of the applicants, do not wish to intervene in the respective cases as a third party,

Having regard to the judgment in the cases of *Preda and Others v. Romania* (nos. 9584/02, 33514/02, 38052/02, 25821/02, 29652/03, 3736/03, 17750/03 and 28688/04, 29 April 2014),

Having deliberated, decides as follows:

THE FACTS

1. The applicants, referred to in the annexed table, have all lodged before the domestic courts various proceedings based on the restitution legislation, adopted in Romania after the fall of the communist regime. Their complaints referring to a general inefficiency of the restitution mechanism were communicated to the Government mainly under Articles 1

of Protocol No. 1 and/or Article 6 of the Convention, on the dates tabulated below.

The Romanian Government (“the Government”) were represented by their Agent, Ms C. Brumar, from the Ministry of Foreign Affairs.

2. On 12 October 2010, the Court adopted a pilot-judgment in the case of *Maria Atanasiu and Others v. Romania*, (nos. 30767/05 and 33800/06), in which it singled out the deficiencies of the restitution mechanism, indicating to the respondent state under Article 46 of the Convention that new steps needed to be taken in order to process the restitution claims with more efficiency.

3. On 15 May 2013 Law no. 165/2013 came into force, setting out various proceedings available to the petitioners seeking to have their restitution claims solved.

4. Based on the parties’ observations and comments regarding the new remedies set out by Law no. 165/2013, on 29 April 2014 the Court found in its judgment of *Preda and Others v. Romania* (cited above, §§ 134-140), that the mechanism established by the new law offered a range of effective remedies that needed to be exhausted by those claimants whose complaints referred to one of the following situations: the existence of concurrent titles to property with respect to the same immovable; the annulment of the title to property in the lack of any compensation; the issue of a final decision confirming the right to compensation without fixing the amount; the failure to pay the compensation allowed in a final decision; and the prolonged failure to give a decision on a restitution claim.

B. Relevant domestic law

5. The applicable domestic legislation is indicated and detailed in the pilot case *Maria Atanasiu and Others v. Romania*, cited above, §§ 44-80; and *Preda and Others v. Romania*, cited above, §§ 69-74.

COMPLAINTS

6. Relying on various provisions of the Convention (see attached table), the applicants complained that their restitution and/or compensation claims, based on the various relevant domestic laws, have not been dealt with in a satisfactory manner by the national authorities, in so far as the respective mechanism put in place by the state was ineffective.

THE LAW

7. The Court firstly finds that, given their common factual and legal background, it is appropriate to join the present applications.

8. The Government raised various objections in relation to certain complaints lodged by the applicants. However, the Court need not examine them separately since the applications are inadmissible in any event for the reasons stated below.

A. Complaints under Article 1 of Protocol No. 1

9. The Court recalls that in *Preda and Others v. Romania* (cited above, § 129), it has held that Law no. 165/2013 provided a framework for the redress of the applicants' complaints under Article 1 of Protocol No. 1 generated by the application of the restitution laws, which was in principle accessible and effective. Hence, in spite of the fact that such a framework became available after the introduction of their applications, it held that the applicants were obliged to use them, in so far as using them did not constitute an excessive burden for them, or for other claimants in a similar position (see §§ 134-140 of the judgment and paragraph 4 above).

Similarly, the Court notes that the same reasoning applies for the situation where the applicants have a final and binding judgment confirming their entitlement to a plot of land, the domestic authorities being under the obligation to restore possession on the respective land and issue the respective title deed by 1 January 2016, pursuant to Article 11 § 1 of the Law no. 165/2013.

10. Having regard to its findings in *Preda and Others v. Romania*, and in so far as the factual situations described above also form the basis of the current applications, the Court concludes that the applicants in the present cases are also required by Article 35 § 1 to avail themselves of the new domestic remedy by pursuing the domestic proceedings under Law no. 165/2013.¹

Having regard to its findings in the above-mentioned cases (see also paragraph 4 above), and in so far as the factual situations described therein also form the basis of the current applications, the Court concludes that the applicants in the present cases are also required by Article 35 § 1 to avail themselves of the new domestic remedy by pursuing the domestic proceedings under Law no. 165/2013."

11. It follows that the present applications, in so far as they concern alleged violations of Article 1 of Protocol No. 1, must be rejected pursuant to Article 35 §§ 1 and 4 of the Convention for non-exhaustion of domestic remedies.

B. Complaints under Article 13 and 46 concerning the lack of an effective domestic remedy and the consequential existence of a systemic problem

12. Given that the applicants' complaints under Article 1 of Protocol No. 1 have been rejected for non-exhaustion of domestic remedies, in so far as the new remedies provided by the Law no. 165/2013 cannot *a priori* be presumed ineffective (see paragraph 9 above), the related complaints under Articles 13 and 46 raised in some of the applications are manifestly ill-founded and must be rejected in accordance with Article 35 §§ 3 (a) and 4 of the Convention.

C. Other complaints

13. The Court has examined the remainder of the applicants' complaints, as submitted by them (see attached table). However, in light of all the material in its possession and in so far as the matters complained of are within its competence, the Court finds that they do not disclose any appearance of a violation of the rights and freedoms set out in the Convention and its Protocols. It follows that the respective parts of the applications must be rejected, pursuant to Article 35 §§ 1, 3 and 4 of the Convention.

For these reasons, the Court unanimously

Decides to join the applications;

Declares the applications inadmissible.
